RE: Legal consultancy for Identity Malta Reform

This engagement letter, which must be retained confidential, describes the terms upon which Hon Edward Zammit Lewis, would be able to provide Consultancy services and includes the fees and billing method for services rendered thereto.

1. **Professional undertaking:** Services will be provided on schedule as shall be agreed and at a reasonable cost.

Hon Edward Zammit Lewis (ID: [REDACTED]) will be specifically assigned thereto to provide Legal Consultancy service with regards to the reform of Identity Malta as agreed with the Government of Malta.


This agreement is effective from the 13/4/2018, for a period of 6 months or up till such reform is concluded, whichever is the earlier, with the possibility of renewing further if the exigencies so require.

2. **Hourly fees:** Fees for services are calculated and based upon the applicable hourly rates, charged at €100 per hour excluding VAT for a maximum of 10 hours per week. The schedule of hourly rates is based on experience, training and level of professional attainment.
3. **Other fee arrangements:** On occasion, and by specific agreement, we may agree to a fee arrangement other than an hourly fee, such as a fixed fee for a specifically defined project. In such a case, the fee and payment schedule will be set forth to you or in a separate agreement or addendum to this letter, but all other terms of this engagement letter will apply.
4. **Costs:** Expenses paid entirely to third parties (such as travel and lodging expenses) will be billed to you at our "out-of-pocket" cost. Expense items incurred on your behalf will be itemised separately and billed on our statements as "disbursements". Third-party expenses may be forwarded directly to Identity Malta for payment.


As is usually the case, expense disbursements may be current at the time of final billing. Remaining disbursements, if any, will be billed at a later date.

5. **Billing statements:** Generally, payment statements are prepared and mailed on a monthly basis. Such statements are payable upon presentation.

7. **Other matters:** Unless both parties agree otherwise, the terms and conditions of this letter will apply to all matters for which engagement was established.
8. **Governing law and submission to jurisdiction:** Maltese law shall apply to the construction and interpretation of our relationship and the Maltese courts shall have exclusive jurisdiction to resolve and disputes arising in relation to it.
